Is a direct cremation plan suitable for me?

If you do not require a funeral service, or you intend that any commemoration of your life is to be arranged outside the scope of a funeral plan, Freeman Brothers' direct cremation plan may be suitable for your demands and needs. There is no option for an attended funeral. Freeman Brothers reserves the right to choose the crematorium, and the day and time of the cremation. If you require an attended funeral service, our Tiered Funeral Plan or Tailormade Funeral Plan may be suitable for you.

Freeman Brothers will provide you with details about the plan you have purchased for you to share with your Nominated Representative. We suggest that any direct cremation planholder ensures that their wider circle of friends and family know that they have planned a direct cremation with no funeral service. Some people can find it hard to accept that there may be no commemoration of your life and having such a conversation enables preferences to be clearly understood. It also gives the opportunity to check other preferences outside of the scope of your plan with you: for example, if you would be happy for those who knew you to have an informal get-together to remember you after you have died.


Note about Freeman Brothers' use of personal data
